## Fast Track fee

For fast track articles the fast track fee is **EUR 350 net**, plus VAT (value added tax), if applicable.

**VAT (value added tax) is applicable only for residents in any European Union country.**

The tax to be added differs per country. The following table shows the current VAT rates per EU country and the resulting fast track fee including VAT.

**Please note:** If institutions or research funders within any European country will make payment for an APC on behalf of an author, and if their VAT registration number is provided, no VAT needs to be charged.
